## INSTITUTE NEWS

### APPPA Convocation

The IIPA organised the convocation of the thirtyseventh Advanced Professional Programme in Public Administration (APPPA) on March 29. Commencing on July 1, 2011, the 38-week programme was sponsored by the Ministry of Personnel, Public Grievances and Pensions. Shri V. Narayanasamy, Union Minister of State for Personnel, Public Grievances and Pensions, as Chief Guest, delivered the convocation address. In his address, Shri Narayanasamy observed that with fast changing governance paradigm, the focus has shifted from the government to governance, which is a dynamic concept and encompasses fast changing political, social and economic milieu along with global environment and conditions of operational governance. For the sustained and successful growth of democracy, he exhorted that it is imperative to address the challenges of growth, equity and other key issues of public governance in an efficient manner. He expressed that corruption is a formidable impediment in our endeavour to use the public systems as efficacious instrument of socio-economic welfare. On this occasion, Shri Narayanasamy released the following publications (i) The Development and Impact of British Administration in India by Bernard C. Cohn; (ii) Corruption, Ethics and Accountability: Essays by an Administrator by Rakesh Hooja; (iii) Government in Action: Development of Case Studies by Rajesh Singh; (iv) Training Civil Servants in the States by Rakesh Hooja, Rajesh Singh and C. Sheela Reddy; (v) Consumer Concerns in 21st Century by Suresh Misra, Sapna Chadah and Mamta Pathania; and (vi) Organisational and Procedural Issues in the Government by R.K. Tiwari and Sujata

Singh. Earlier, tracing the genesis of the programme, Dr. Rakesh Hooja, Director of IIPA, highlighted the objective, content and methodologies of the programme and also the future plan to make it more customised one. Congratulating the participants on their success, Shri T.N. Chaturvedi, Chairman of IIPA, called upon them to be perceptive, reform-minded and clairvoyant. Prof. K.K. Pandey, Programme Director, presented a resume of the programme detailing its content. In his vote of thanks, Prof. N.P. Singh, Chairman of IIPA's Standing Committee, emphasised on leadership, innovation and awareness to face the dizzying array of challenges in the path of progress. Participants drawn from All-India and other Central services including defence services attended the programme.

### Justice H.R. Khanna Centenary Lecture

The Institute teamed up with the Universal Law Publishing Co. and the Khanna family in organising the captioned lecture on March 16. Shri Soli Jehangir Sorabjee,

Senior Advocate, Supreme Court, delivered the lecture on “Judiciary—Protector of the Constitution”. Justice Deepak Verma, Judge, Supreme Court of India, presided over the programme. In his address, Shri Sorabjee stated that Constitution embodies the fundamental values and the philosophy, on which it is based, and the aims and objectives, which the founding fathers of the Constitution enjoined the polity to strive to achieve. Discussing Justice Khanna’s outstanding judicial acumen, impeccable honesty and ferocious rectitude, Shri Sorabjee recalled some of his memorable and landmark judgements that had far-reaching effects on the lives of the masses. Calling upon the legal fraternity, he emphasised that courage as shown by Justice Khanna while dealing with cases is what is required. Earlier, in his welcome address Dr. Rakesh Hooja, Director of IIPA, mentioned about Justice Khanna’s achievements and his commitment to moral values. In his presidential address, Justice Verma called Justice Khanna as the legendary figure in the legal fraternity. He called upon the judges and advocates to imbibe Justice Khanna’s great qualities to become perfect gentlemen. During the programme,

### National Seminar on Development and Weaker Section: Issues and Challenges

The Institute organised the captioned programme on March 5-6. The seminar focused on the various issues related to the weaker section’s estrangement and alienation. During the deliberations, development and its meaning with weaker section; the issues of SCs, STs, OBCs; gender; panchayati raj and other decentralising concerns; ecology and economy; caste-based politics and indigenous movements as the reaction to development were discussed. Dr. K.N. Jhangir, Consultant, ICSSR; and Dr. Rakesh Hooja, Director of IIPA, spoke in the inaugural session. In the first technical session on “Development: Its Meaning with Weaker Sections” six papers were presented. Prof. T.K. Oommen chaired the session. In the second technical session on “SCs, STs, OBCs and Gender for Development” nine papers were presented. Prof. Sheo Bahal Singh chaired the session. In the third session on “Panchayati Raj and Decentralisation Concerns for Weaker Sections” five papers were presented. Prof. E. Haq chaired the session. In the fourth session on “Ecology and Economy: A Concern for Weaker Sections” six papers were presented. Prof. R.K. Barik chaired it. In the final session on “Caste-based Politics, Indigenous Movement: A Concern for Weaker Sections” eight papers were presented. Prof. Sushma Yadav

chaired it. Shri Saket Bihari, Dr. C. Sheela Reddy and Dr. Manan Diwedi coordinated the programme.

### **Awareness Workshop on Data Management and its Importance**

Sponsored by the Central Pollution Control Board, the programme was conducted at IIPA on March 2. The programme was designed to familiarise the participants with importance of data, its generation, acquisition, validation, storage and retrieval; and application of statistics on water quality analysis. The faculty comprised guest speakers and the programme coordinator, Prof. Vinod K. Sharma.

### **Programme on Consumer Protection and Consumer Welfare**

Sponsored by the Ministry of Consumer Affairs, Food and Public Distribution, the captioned programme was conducted at IIPA by its Centre for Consumer Studies, for Heads/ Presidents/Secretaries/Directors of NGOs/VCOs from March 12-16.

Apart from enhancing the participants' knowledge and skill in the area of consumer protection and consumer welfare, the programme was designed to enable them to: (i) comprehend the need and importance of consumer protection and welfare; (ii) acquaint with the national and international dimensions of consumer protection and the role of various stakeholders; (iii) explain the various provisions of the Consumer Protection Act and other legislation on consumer protection; (iv) discuss the legal dimensions of consumer protection in different services sectors such as housing, healthcare, banking, insurance, etc; and (v) develop training skills. The faculty comprised guest speakers and in-house faculty. Prof. Suresh Misra and Dr. Mamta Pathania coordinated it.

### **Programme on GIS Application and Water Quality**

Sponsored by the Central Pollution Control Board, the programme was

conducted at IIPA from March 15-17. Coordinated by Prof. Vinod K. Sharma, the programme was designed to enable the participants to: (i) understand the need of GIS for water quality management; (ii) understand scientific investigations, resource management and development planning through GIS technology; (iii) know capturing, storing, analysing and displaying geographically referred information for development of GIS; (iv) study water quality monitoring and management—a case of river Yamuna; (v) understand data/topological modeling—isolines, computer maps, combination of graphics/tables on map, inter-relationship of values within and between the sites; and (vi) learn overlay and data output graphics, maps and export information. The faculty comprised guest speakers and in-house faculty.

#### **EXTENSION OF THE DATE OF SUBMISSION OF MEMBERSHIP FORMAT**

“The Executive Council after considering the representations and the legal opinion thereon, has decided in its Meeting held on 28/3/2012 that the eligible members as per Rule 30(2) of the Memorandum of Association & Rules of the Institute, members who have not submitted their membership details on prescribed format by 31/01/2012 may be given a final opportunity to submit the same by 27/4/2012. Accordingly all such members who have not submitted their membership details on prescribed format are required to submit the same directly to the Director, IIPA so as to reach before 27/4/2012. Any format received after 27/4/2012 will not be included in the voter list of the Institute as on 31/3/2012.”

#### **AMENDMENT IN THE ELECTION BYE-LAWS OF INSTITUTE**

The Executive Council in its Meeting held on 28/03/2012 approved the recommendations of the Standing Committee for the following amendment in the Election Bye-laws of the Institute:

In Rule 19 the following may be added after (vi)

“(vi a) The giving of one's ballot paper to any other person, or receiving of any other member's ballot paper, since each ballot paper is meant to be handled only by the member who has a right to vote.”

And accordingly existing para (vii) of Rule 19 may be read as follows:

“(vii) Any member found indulging in unethical practices referred to in Rule 19(i) to (vi a) shall be debarred from voting for a period of eight years. Any contestant found indulging in malpractices shall be debarred from contesting all future elections to the Executive Council of the Institute”.

Accordingly the para 10 of the election related notification will also be changed.

### Barcoded Library Tickets for Annual/ Associate/ Student/ Life/ Corporate Members

As per the Library Advisory Committee decision regarding the automation of Circulation Section in the Library, to operate the library in an fully automated environment in six months. The new barcoded tickets are compulsory for all the members of the library who have deposited the library security of Rupees one thousand and five hundred respectively. The barcoded tickets are being prepared and the cost of preparing these tickets is Rupees twenty per ticket. Members desirous of receiving the same by post may remit Rs 65/ (including the postage charges). This cost is for the members who have deposited Rs 1000 as library security. Those members who have deposited the library security of Rs 500 may remit Rs 45 (including the postal charges) by means of a demand draft in favour of Director, IIPA payable at New Delhi or may collect it from the library on payment of Rupees twenty or forty in the accounts section for one or two tickets respectively

External Affairs, the programme was conducted at IIPA from March 19-30. Dr. Rakesh Hooja, Director of IIPA, gave the inaugural address on "What Nepal could learn from India". Besides understanding India-Nepal economic cooperation and Indo-Nepal political relations, the programme was designed to enable the participants to: (i) know the Indian federal structure and democracy; (ii) discuss development concerns and study the internal security issues of both the countries; and (iii) understand inter-basin water management and non-conventional source of energy programme in India. The faculty comprised guest speakers and the programme coordinators, Prof. Vinod K. Sharma, Prof. Suresh Misra, Dr. C. Sheela Reddy and Dr. Manan Dwivedi.

### Workshop on Communication and Presentation Skills

Sponsored by the National Academy of Statistical Administration, the programme was conducted at IIPA for NASA officials from March 21-23. Apart from identifying the essential elements of communication, the programme was designed to enable the participants: (i) analyse the effectiveness of his/her current style of communication; (ii) discuss barriers to communication and strategies to deal with difficult people; (iii)

develop skills of presentation at seminars, workshops, meetings, etc: (iv) provide skills in preparing and designing presentation materials; and (v) improve communication by using feedback tools. Prof. Sushma Yadav coordinated it.

### Workshop on Right to Information

Sponsored by ONGC Academy, Dehradun, the programme was conducted at IIPA on March 26. Besides comprehending the aims and objectives of the RTI Act, the programme was designed to enable the participants to: (i) get a first-hand knowledge on how the Act is being implemented; (ii) appreciate the view points of the supposed beneficiaries of the Act; and (iii) secure a better understanding of the tasks as a PIO through participative deliberations, potential pitfalls and possible solutions. The faculty comprised guest speakers and the programme coordinator, Prof. Sushma Yadav.

### Programme on ICT and e-Governance Skills Development

Sponsored by the Andaman and Nicobar Administration (Department of Information Technology), the programme was conducted at IIPA for the IT cadre officials of Andaman and Nicobar Administration from March 26-April 6. The programme

was designed to enhance the ICT and e-governance skills of the participants so that they can play their role more effectively and can assume higher responsibilities in the department. The faculty comprised guest speakers and in-house faculty. Shri S.R. Das coordinated it.

### Workshop on Mobilizing the Information and Knowledge Society: Crossed Perspectives from SAARC Countries

The 2nd International Workshop on Mobilizing the Information and Knowledge Society : Crossed Perspectives from SAARC Countries was organised by IIPA in collaboration with UNDP, Accenture, NIDM, DESIDOC, DRDO and OneWorld South Asia as knowledge partners on March 30-31, 2012. The Workshop was coordinated by Dr. Usha Mujoo Munshi and Prof. Vinod K. Sharma and conducted by Dr. Charu Malhotra. The workshop focused on contextual factors of development with respect to various aspects of knowledge societies with special reference to SAARC region.

The workshop was attended by a galaxy of 50 eminent experts from industry, academia and policy making institutions including IIT, JNU, SAU, STQC, NIC, DRDO, MHRD, Corporate bodies like Accenture, Microsoft and members of the civil

society. The speakers expressed their views through four thematic sessions on (i) Key Challenges in Knowledge Management in Development Context; (ii) ICT- Led Knowledge : Capacity Building for Knowledge Societies Connecting Strategies through KM; (iii) Mainstreaming Indigenous Knowledge Across the Region in Disaster Risk Management; and (iv) Dynamics & Elements of Knowledge Based Society

This workshop was based on the rationale of creation of domain based knowledge foundation with ICT as the key enabler. It was felt that the exchange of ideas in these sessions would help all the stakeholders of knowledge society. The workshop had helped to collate diverse perspectives, and various nuances such as relevance of contextualisation and the policy formulation in a developing and diverse country like India. The deliberations also clearly highlighted that the SAARC countries have a number of common concerns and challenges and even some commonalities in their culture. Sharing problems and finding solutions will uncover new vistas for sustainable development for the region. Keeping these priorities in mind, the participating experts presented those aspects of knowledge management including risk management issues, which are about applying the collective knowledge while fine combing them through knowledge sharing sessions.

#### International Women’s Day

The Department of Personnel and Training (DoPT) organised a Workshop to mark International Women’s Day at IIPA on March 9. Shri V. Narayanasamy, Union Minister of State for Personnel and PMO, delivered the inaugural address. Dr. Rakesh Hooja, Director of IIPA; and Dr. S.K. Sirker, Addl. Secretary, DoPT, also addressed in the inaugural session. Ms. Upama Srivastava, Joint Secretary, Training; and Ms. Mamta Kundra, Joint Secretary, Administration, DoPT, also participated. Women functionaries of DoPT and some other women employees from other agencies

including IIPA participated. Prof. Sujata Singh coordinated with DoPT officers in organising it.

### Workshop on Impact of Quota System on Women's Empowerment

The Institute organised the programme on March 28 to discuss issues pertaining to quota system and its impact on empowering women. Shri Mani Shankar Aiyar, former Minister of Panchayati Raj, delivered the key-note address. He mentioned that we have more than 1.3 million politically elected women representatives in the country and there is not much objection to women occupying positions of power and authority. Also that the lower a woman is on a social/economic scale, the more likely she is to be empowered

politically. Thus, in Karnataka the participation of SC/ST women is 65 per cent as against 32 per cent from the general category. Shri A.N.P. Sinha, former Secretary, Ministry of Panchayati Raj, gave an overview and summed up the programme. The workshop addressed the following issues: (i) "Can Political Reservations Empower Women and Affect Economic Outcomes: Evidence from Rural India"; (ii) "Can Political Reservation Affect the Quality of Participation of EWRs: A Case Study of Bihar"; (iii) "Training and Capacity Building for Women's Empowerment"; (iv) "Voices from the Panchayat"; and (v) "From Representation to Participation to inclusion". About 40 participants including experts, development practitioners, administrators, policy

makers, social activists attended the programme. Prof. Aasha Kapur Mehta, Shri Saket Bihari and Dr. Nupur Tiwari coordinated it.

### Workshop on Ethics in Public Service

IIPA's Centre for Values and Ethics in Public Affairs organised a workshop on "Ethics in Public Service" on March 21. Justice J.S. Verma, former Chief Justice of India, delivered the inaugural address; and Shri T.N. Chaturvedi, Chairman of IIPA, presided over the inaugural session. Dr. Rakesh Hooja, Director of IIPA, welcomed the gathering. The key speakers of the workshop were Swami Bodhananda, eminent teacher of Vedanata and Yoga; Shri B.P.
