Prime Minister and UPA Chairperson gave away awards to States based on IIPA Study

On the occasion of National Panchayat Diwas, Prime Minister, Dr. Manmohan Singh and UPA Chairperson, Smt. Sonia Gandhi gave away the awards to states ranked high on the Panchayat Devolution Index computed by the study carried out in IIPA by Dr. V.N. Alok and Prof. P.K. Chaubey. The Ministry of Panchayati Raj organised the ceremony at the Vigyan Bhawan Plenary Hall on April 24. On this occasion, Shri Vilasrao Deshmukh, Union Minister for Rural Development and Panchayati Raj, welcomed panchayat representatives from all states and UTs. Prime Minister and the UPA Chairperson addressed the gathering. Shri A.N.P. Sinha, Secretary, Ministry of Panchayati Raj, proposed the vote of thanks and urged the Prime Minister to accord centrality to panchayats in the 12th Five Year Plan. In the second session, Shri Deshmukh, launched the report prepared by IIPA and published by the Ministry of Panchayati Raj. The first copy was presented to Shri Mani Shankar Aiyer, Member,



State Ministers in-charge of panchayts could be seen along with Mani Shankar Aiyer, Vilasrao Deshmukh, V N Alok and A N P Sinha, Secretary, Ministry of Panchayati Raj. Shri Deshmukh, Union Minister released the book

Rajya Sabha and former Union Minister of Panchayati Raj. On the basis of the study of IIPA, incentive awards were given to the states for cumulative achievements under the Panchayat Empowerment and Accountability Incentive Scheme (PEAIS). Kerala got the first prize followed by Karnataka. Sikkim received the third prize while West Bengal got the fourth prize. In addition, for the first time, states were awarded for the initiatives taken by them since April 1, 2009. These initiatives were ranked along the parameters of (i) Institutional strengthening of panchayats; (ii) Improvement in process; and (iii) Improvement in delivery of services. As per the Incremental Panchayat Devolution Index, Rajasthan received the first prize; Kerala though ranked second did not receive the cash prize due to its first rank in the Cumulative Panchayat Devolution Index. Maharashtra received the third prize. Shri Bhupinder Singh Hooda, Chief Minister of Haryana, was present to receive the fifth prize under the Incremental Panchayat Devolution Index. This is the second successive year that the Prime Minister gave away awards to the states on the basis of the study conducted at the Institute on Panchayat Devolution Index.

Programme on GIS-based Mapping for Urban Development

Sponsored by the Ministry of Urban Development, the captioned programme was conducted at IIPA. for officers drawn from various urban bodies, from April 18-22. Apart from sensitising the participants to efficacy of remote sensing and geographic information systems in urban development, the programme was designed to introduce: (i) the basic concepts of GIS and remote sensing; (ii) components of successful GIS operation; (iii) application of GIS in various fields; (iv) examples of GIS applications in urban planning and development; and (v) networking with participants for knowledge sharing. The faculty comprised quest speakers and the programme coordinator, Dr. Kusum Lata.

Programme on Consumer Protection and Consumer Welfare

Sponsored by the Ministry of Consumer Affairs, Food and Public Distribution, the programme was

organised for the coordinators of consumer clubs at IIPA by its Centre for Consumer Studies from April 25-29. Apart from understanding the need and importance of consumer protection and the role of students in consumer awareness, the programme was designed to enable the participants to: (i) impart knowledge about the role of consumer clubs in protection of consumer rights; (ii) acquaint themselves about Consumer Protection Act and other sectors like food safety, services, standardisation and certification; (iii) enhance their skill to manage consumer clubs; and (iv) develop motivational and communication skills to enhance the functioning of the clubs. The faculty comprised guest speakers and inhouse faculty. Prof. Suresh Misra and Dr. Mamta Pathania directed it.

Vietnamese Delegation Visits IIPA

The delegation informed that under Program 165 they would like IIPA to conduct two or three weeks programmes for Vietnamese participants as per the mutual convenience for which a detailed discussion will be held in due course. They also visited the classrooms and Computer Centre and evinced their satisfaction and expressed hope that the collaboration between the Vietnam Government and IIPA would mutually benefit both.

CPRC-IIPA Report at Orissa Seminar

Prof. Aasha Kapur Mehta moderated one of the sessions at a seminar on "Orissa at Crossroads: Emerging Aspirations and Contestations" at Xavier Institute of Management-Bhubaneswar (XIMB) on April 24. The programme was organised by Gujarat Institute of Development Research (GIDR), XIMB and Samadrishti, under the aegis of the Chronic Poverty Research Centre (CPRC). This is part of a series of events organised by CPRC-India for disseminating the "India Chronic Poverty Report: Towards Solutions and New Compacts in a Dynamic Context" that was published by IIPA in February 2011. It deliberated on a number of issues to try to understand the dilemma and possibly explore

a new pathway for a sustainable, equitable and sectorally balanced development that could directly address the issue of chronic poverty faced by a large proportion of people within Orissa. A tribute was paid to Prof. Sakti Padhi who passed away almost a year ago.

His contribution to the work of CPRC India (located at IIPA) was significant. New CPRC-IIPA Working Paper Number 51 on Tribal Movements and Livelihoods by Prof. Sakti Padhi and co-authored with Dr. Panigrahi was released during the inaugural session of the seminar by Shri Jugal Mohapatra, Principal Secretary, Finance, Government of Orissa. A copy of the India CPR was presented to him and also to Dr. R.V. Singh, Secretary, Planning, Government of Orissa, who moderated one of the sessions. Over 60 participants from within and outside Orissa attended the seminar. Participants included academics, activists, policy makers, and concerned civil society members. Issues covered during the seminar included: (i) recent developments in the economy and the policy paradigm, fiscal resources, and poverty scenarios; (ii) sectoral dimensions of the opportunities and challenges at the present juncture of the state's economy; (iii) new policy spaces created through the rights based approach (RBA) adopted at the central level of policy making and the problems faced at the stage of implementation; (iv) emergence of the new forms of protests and mass movements; and (v) the way forward. Prof. Amita Shah asserted that much of what has been discussed and proposed by way of future pathways has been at least partly covered in the India Chronic Poverty Report, and noted that the report is just a beginning of a process of a continued dialogue, dispassionate enquiries, and policy advocacy as well as field actions. Prof. Aasha Kapur Mehta illustrated this point by highlighting how coordinated efforts by various groups have actually led to the recent modifications by Planning Commission in the poverty line used for estimating poverty in India. Prof. Anand Kumar emphasised the four major deficits that the country is facing that include deficits of development, legitimacy, governance, and democracy and argued that the perpetuation of these deficits for long has created yet another crisis-that is of time deficit or impatience for results.

"Know India" Programme

IIPA facilitated the Ministry of Overseas Indians by arranging one-day session during the Ministry's four-week "Know India" programme for young persons of India origin (PIO) visiting India for first time. Dr. Rakesh Hooja spoke on "Understanding India: A Survey of Political, Economic and Social Developments Since 1947". Prof. Rajesh Singh conducted the ice breaking session; and Smt. Charru Malhotra conducted a session on participants' expectations from the course. Twentyfour participants from six countries attended it.

E-Post Office Launched

Union Minister of Communications and Information Technology(C&IT) launched 'e-post office', the e-Commerce portal of India Post on March 9, 2011. The portal will enable the customers to transact postal business any time and from anywhere using either debit card or credit card through the medium of internet.

The 'e-Post Office', an ambitious project of India Post, will offer seven services in the first phase. These services are Electronic Money Order (eMO). Instant Money Order (iMO). Sale of Philatelic Stamps, Postal information, Tracking of Express and International Shipments, PIN Code Search and Registering of feed back and complaints. One of the focus areas of the first phase of 'e-Post Office' is on the Money Order service. Launched in 1880, the original paper based system of money orders is still in vogue. Though India Post has introduced electronic variants in the form of eMO and iMO, the 'e-Post Office' will revamp the money order thoroughly, after 130 years of its launch, by harnessing the state-of-art information technology.

National Mission for Manuscripts

The National Mission for Manuscripts (NMM) was created by the Department of Culture, Government of India, the Mission came into existence on February 5, 2003. The objectives of the Mission are: to facilitate conservation and preservation of manuscripts through training, awareness and financial support; to document and catalogue Indian manuscripts, wherever they may be, maintain accurate and up-todate information about them and the conditions under which they may be consulted; to promote ready access to these manuscripts through publication, both in book form as well as in electronic form; to boost scholarship and research in the study of Indian languages and manuscriptology; and to build up a National Manuscripts Library at IGNCA. The strategy adopted for this purpose has been as follows: Documentation Creation of Manuscript Resource Centres that supply data regarding manuscripts in their specified areas (at present 46 MRCs), National Survey, Post Survey; Conservation Creation of Manuscript Conservation Centres for preservation and conservation of manuscripts in their specified areas (at present 33 MCCs). Training programmes for Conservation (Preventive and Curative), preventive and curative conservation to manuscripts where the holders ask for it; Organising Awareness Campaigns through outreach programme. Lectures, Seminars / workshops and exhibitions.

The NMM has been able to create a database of 30.67 lakh manuscripts; these are edited and corrected for accuracy by the in-house staff before being released into public domain.

Pay Hike for NREGS Workers

The Union Government has revised wages of agricultural labourers under the Mahatma Gandhi National Rural Employment Guarantee Scheme. The new wages are based on the consumer price index (CPI). Linking wages to CPI has enhanced them from 17 per cent to 30 per cent. The revised salaries would benefit more than 50 million people across India. The base wage, which was Rs. 100 as on April 1, 2009, is revised once in five years. As per the new wages, the highest pay is in Nicobar district with Rs. 181 per day, closely followed by Haryana at Rs. 179. The most poorly paid are those in the north-eastern states. Labourers in Meghalaya get Rs. 117 per day and those at Nagaland, Sikkim and Tripura Rs. 118 per day. Now, MNREGS aims at enhancing the livelihood security of people in rural areas by guaranteeing 100 days of wage employment in a financial year to a rural household whose adult members volunteer to do unskilled manual work. In Karnataka. wages have been hiked from Rs.100 to Rs. 125. Dharwad is among districts selected for an award for implementation of the scheme.

Delhi

Mamta Scheme

Maternal quality healthcare has always been on top of the agenda of the government. Small wonder then that the Delhi government came up with the Mamta Scheme. An important component of healthcare aimed at reducing the Maternal and Infant Mortality is provision of "Institutional Delivery" for pregnant women. In Delhi, approx. 3.2 lakh deliveries take place every year and 63 per cent (as per NFHS 3 survey report, 2005) of these are institutional

deliveries. There are pockets of populations within the NCT of Delhi with much lower rates of institutional deliveries.

The Government is trying to universalise institutional deliveries. However, there are constraints like lack of adequate government health facilities equipped and functional to provide the comprehensive obstetric services for the mother and the newborn and overburdened government hospitals. Under the scheme, healthcare services for the beneficiary would include: (i)

at least three ante-natal check-ups with all necessary investigations including ultrasound of pregnant woman registered; (ii) provision of injection TT and Iron Folic Acid tablets to all pregnant women as per RCH Schedule; (in) provision of institutional delivery facilities, including emergency obstetric care to all registered pregnant women and essential new born care to the new born including administration of birth doses of vaccines to newborns. The eligibility criteria for beneficiaries under the scheme include: the

pregnant woman must belong to the BPL / SC / ST category and should be a resident of Delhi; she should not be less than 19 years of age and she should not have more than one living child. The woman delivering under the scheme will also be entitled for cash incentive of Rs. 600 available under Janani Suraksha Yojna. If she delivers a girl child then the girl child will be entitled to receive benefits under 'Ladli Scheme', a scheme of Directorate of Social Welfare of

Government of Delhi.
