## Stakeholder Workshop on Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013

A workshop on the above theme was conducted at IIPA on May 27. Designed to bring together officers involved in implementation at Central, states and district levels, as also, the representatives of civil society organisations, activists, social workers, scholars and researchers working on the issue,

the workshop aimed understanding both experiences of successful interventions and problems encountered in different context and to draw lessons from these to move forward. The workshop deliberated on the following themes: (i) survey of insanitary latrines and their conversion/demolition; (ii) survey of manual scavengers; rehabilitation of manual scavengers; and (iv) institutional mechanism for implementation of the Act. Dr. Tishyarakshit Chatterjee, Director of IIPA, delivered the inaugural address; and Shri T.R. Meena, Secretary of National Commission for Safai Karamcharis, gave the keynote address. Other speakers included Shri Bezawada Wilson, Founder, Safai Karamchari Andolan and Shri Paul Divakar, General Secretary, National Campaign for Dalit and Human Rights. Around 90 society officers and civil representatives from seven states participated. The workshop was sponsored by Dr. Ambedkar Foundation, Ministry of Social Justice and Empowerment and was coordinated by Prof. Dolly Arora.

# **NEWS FROM BRANCHES**

### **Assam Regional Branch**

The branch organised a discussion-meeting on April 26, in which Prof. R.C. Borpatra Gohain, Dean of Law Faculty, Gauhati University, delivered the key-note address on "Directive Principles of Indian Constitution and Inclusive Growth". Shri Jatin Hazarika, Chairman of the branch, presided over the programme.

# Jammu and Kashmir Regional Branch

The branch organised a lecturemeeting on May 13, in which Prof. Gopalji Malaviya, Dean, School of National Security Studies at the Central University of Jammu spoke "Security Governance on Challenges for the New Government". He proposed two hypotheses (i) need for a shift of security paradigm both at internal and external level; and (ii) need for a stable government for robust security architecture. Dr. S.S. Bloeria, Vice-Chancellor of the Central University of Jammu, cautioned that Pakistan may test the waters by some provocative action to see the reflexes and response of the new government. Earlier Dr. Ashok Bhan, Chairman of the branch, explained how proxy war that the country faces from across its borders has obliterated the distinction between external security and internal security necessitating cooperation between the Union Government and the states. Earlier, the branch organised a workshop-cum-seminar on "Efficient Delivery of Public Services

through e-Governance" on May 2. Shri Amit Sharma, Special Secretary to Government, Animal/Sheep Husbandry Department, delivered the key-note address. He proposed various e-governance solutions for various departments of the State Government. He further observed that the future of e-governance is mobile governance models (mgovernance), which would help government departments to reach out to the last mile users and provide maximum services through mobile phones. It was followed by a case study presentation by Dr. Suparn Sharma, Director of School of Business, SMVDU, regarding successful implementation of MIS in sugarcane industry in Uttar Pradesh. Shri D.S. Bali, Addl. CEO of JKeGA; and Shri Shafqat Bashir, Principal Consultant, expressed their opinion on egovernance. Earlier, in his opening remarks, Dr. Ashok Bhan mentioned about the significance of egovernance in taking administration to the doorsteps of aam admi.

#### Karnataka Regional Branch

The branch has set up a Centre for Consumer Studies in Begaluru, which was inaugurated by Dr. A. Ravindra, former Chief Secretary, GoK on April 5. Shri S. Ramanathan, Chairman of the branch, stated that the consumer movement in Karnataka needs to be strengthened by way of training, advocacy and capacity building. Smt. Sujatha Hosamani, Joint Director, State Department of Food, Civil Supplies and Consumer Affairs, expressed her best wishes to the CCS and the

# Integrated Watershed Management Programme

The Integrated Watershed Management Programme (IWMP), one of the flagship programme of Ministry of Rural Development, is under implementation by the Department of Land Resources since 2009-10 after integrating three area development programme namely Desert Development Programme, Drought Prone Areas Programme and Integrated Wastelands Development Programme for development of rainfed/degraded land in the country. The main aims of IWMP are harnessing, conserving and developing degraded natural resources such as soil, vegetative cover and water; prevention of soil run-off; rain water harvesting and recharging of the ground water table; increasing the productivity of crops; introduction of multi-cropping and diverse agro-based activities; promoting sustainable livelihoods and increasing the household incomes. The major activities taken up under IWMP, inter-alia, include ridge area treatment, drainage line treatment, soil and moisture conservation, rain water harvesting, nursery raising, afforestation, horticulture, pasture development, livelihoods for asset less persons. The Department of Land Resources has sanctioned 6622 projects covering an area of 31.29 million hectare and has released the Central assistant of Rs. 8240.61 crore to the states under IWMP since its inception in 2009-10 to 2013-14 (till November 2013). The project duration of IWMP project varies from four to seven years. Though the IWMP projects are yet to be completed, the impacts are now visible in many parts of the country. The construction of water harvesting structures under IWMP has helped in improving the water availability and additional income to the farmers living in the project areas.

### Model e-Villages for Bridging Digital Divide

The Centre for Development of Advanced Computing (C-DAC), and College of Horticulture and Forestry (CHF), Central Agricultural University, Arunachal Pradesh designed a model e-village project that would create computer infrastructure in the remote tribal areas of North East India to create e-literacy among the community. The basic objectives of designing and implementing this project are to make the village community, especially the youth, aware of the benefits of e-knowledge in different aspects of everyday life and to take ICT closer to farmers for improving their agricultural methods and output. The pilot phase of this project started in June 2008 and completed in March 2011. Ten villages of the East Siang District of Arunachal Pradesh were selected for the pilot. A baseline survey conducted during the initial phase of the pilot helped in designing the project according to the identified needs and aspirations of the community. With the inauguration of the project, ten e-village centres were set up, which were equipped with computer, printer, scanner, wireless Internet connection (EVDO) and DTH (Direct-to-home) TV and provide printing, scanning and internet facilties to the villages. A mini library, having technical publications in agriculture and allied sectors, was also established to facilitate eknowledge in agriculture among the community. The project has been successful in creating e-literacy and in building capacity of the community to use ICT for improving their livelihood and education. During its pilot, 54 training programmes were conducted that benefited 1640 farmers in obtaining advanced information on agriculture sector. Seven community e-awareness programmes conducted through evillage centres also benefited more than 800 students. Various with multimedia documents components on new technology and innovations in agriculture are made available to the community to facilitate adoption of modern techniques and to build their entrepreneurial skills. This project also helped in disseminating multilingual content of India Development Gateway (InDG) portal that related to agriculture, health, primary education, rural energy, e-Governance and social welfare. The success of the project indicated a strong case for replication in various remote areas of India. Although the pilot of the project is over, scale up proposal has already been submitted to the Department of Electronics and Information Ministry Technology, of Communications and Information Technology, through C-DAC for approval.

# **NEWS FROM STATES**

#### Delhi

#### Safe Delhi Campaign

The Safe Delhi Campaign aims to create an inclusive city, where women do not have restrictions on their mobility and can access public spaces freely. It seeks to do so by partnering with civil society organisations, the police and the government. Over the last few years, the issue of women's safety has come to the forefront in Delhi. Everyday there are newspaper reports about the harassment that women face in Delhi and the constant state of fear that they have to live in. JAGORI-a women's training, documentation, communication and resource centre that seeks to build capacity and spread awareness about women's safety and fight for gender equalityinitiated a 'Safe Delhi Campaign' with the aim of making people from the city more aware about the problems that women face and to develop strategies via which women can access public spaces in Delhi without constantly worrying about their safety. This campaign asserts that women have the right to live, to work and to move around with safety and dignity. Its strength lies in creating partnerships with various stakeholders and stressing on the fact that violence against women is not just a 'women's issue' and that NGOs, citizens groups and community organisations, educational institutions, industry, the police and law enforcement agencies, the administration and elected representatives all have a role to play in ensuring women's safety and security. It has successfully created a mass support base and highlighted the need to address women's safety at a policy level and brought the issue to the forefront.

#### Karnataka

#### **Drought Management**

This project is designed to predict drought by using scientific methods, tools and data to prevent its occurrence; and respond to mitigate the effects of drought through drought relief and drought proofing measures. This is a multilevel institutionalised drought monitoring and early warning system that can be used in normal and drought periods. It can operate and perform the functions of monitoring, mitigation, preparedness, vulnerability mapping, and declaration; and accordingly carry out funding and relief operations in drought affected areas. It also uses ground-based data and data obtained from space technologies such as remote sensing and vegetation mapping for prediction purposes. This improved drought management system has resulted in reducing poverty levels in droughtaffected states. There is a shift in from methodology crisis management (traditional approach) to risk management. It involves a

holistic approach to drought management, which includes forecasting, prevention, mitigation and preparedness in pre-drought phase along with post-drought measures of relief, rehabilitation under crisis management.

# Electronic Integration of BHOOMI with Stakeholders

The State Government jointly with National Informatics Centre as technical partner has implemented a land records management system, BHOOMI, to bring reforms in the area of land administration. Previously, farmers were solely dependent on village accountant to get a copy of the record of rights, tenancy and crops leading to delays and harassment. Most significant achievement of BHOOMI has been electronic integration stakeholders like registration department, land acquiring bodies, banks and financial institutions. These electronic integrations have resulted in reducing/removing human discretion and streamlined various land records administration activities making records of rights current with respect to various activities happening in the external environment pertaining to land records. Web presence of BHOOMI has helped citizens to have easy access to their records. This is evident from the fact that on an average BHOOMI website gets one lakh hits per month. BHOOMI website also enables citizens to

check the status of transactions in which their lands are involved.

#### **Trash to Treasure**

In India, waste collection is an unorganised sector that suffers from enforcement of waste management laws. In order to address the concerns, the Cooperative Housing Foundation (CHF) International introduced a decentralised model of waste management to improve facilities and support livelihoods. The initiative, named Trash to Treasure,

is funded by the Bill & Melinda Gates Foundation and Caterpillar to revamp the waste management and recycling industry in Bengaluru. The project has two implementation models. One is a traditional approach where waste is collected directly from 2000 households in Rajendranagar and Ambedkarnagar area, and taking it to a facility centre to sort them for recycling purposes. These centres are known as Parivarthana meaning 'change'. Second model includes collection

of waste from BBMP employees in Kasa Rasa centre. The centre is managed by Saahas, CHF's partner specialised in waste and recycling management. Saahas supervises the centre's staff, manages the operations and manufacturing of compost heap in organic waste convertor machines and finally sell it to recycling entrepreneurs. In all three areas, BBMP has provided the space to construct centres for waste sorting and recycling services.
