# Background:

Gender Budgeting has been adopted by Government of India as a tool to facilitate a gender sensitive analysis in the formulation, implementation and monitoring of policies, programmes and budgets (expenditure and revenue). To facilitate this the Ministry of Women and Child Development, Government of India. As a part of the Mission Shakti: Gender Budgeting Scheme of the MWCD, GoI, it has been facilitating and organising various training programmes and workshops on Gender Budgeting. The Indian Institute of Public Administration is pursuance of this is organising a national level training program on gender budgeting for the officers of the Central Ministry/Department/Attached & Subordinate Offices/ Public Sector Undertakings / Autonomous Bodies /Research Institutions /Universities.

# Objectives:

- To equip officers working with the requisite knowledge and skill related to gender
- To introduce the concept, tools and methodology used in Gender Budgeting;
- To promote and discuss ideas and themes related to gender as a priority concern in development planning and implementation.
- To introduce and facilitate participants for gender sensitive review of national policies such as fiscal, monetary, environment, trade etc.
- To share challenges, experiences, and achievements of Gender budgeting committee.

## Course Capacity:

The maximum number of participants that can be admitted to the course is 50.

# **Eligibility Conditions:**

Nominations from the officers from the Gender Budget Cells; Plan, Policy, Coordination, Budget, Accounts Division/ Others, preferably calling for the nominations of Section officers, Under Secretary and Deputy Secretary in the respective Ministry/Department/ Attached & Subordinate Offices/ Public Sector Undertakings / Autonomous Bodies /Research Institutions

#### Methodology:

The training will be conducted through Lectures by the trainer (using PowerPoint presentations, overhead projectors, etc.), Group discussion, Exercises, Case studies, Roleplays, Buzz groups (usually small groups consisting of three to six people who are given an assignment to complete in a short time period), Presentations by participants and Calculation exercises.

#### Nominations or The Course

Eligible and interested officers may be nominated for the course. The particulars of the nominees may be sent to the programme coordinator so as to reach before 28th June 2024.

#### Acceptance of Nomination

Candidates whose nominations are accepted by IIPA shall be intimated through email. No separate communication by post would be issued by IIPA and therefore the Controlling Authority/Participants are advised to check their emails regularly. The nominees are to be relieved for attending training only after receiving confirmation from us.

#### Accommodation

The workshop is a non-residential training programme. However, hostel facilities are available at IIPA for outstation participants on nominal payment on single / twin sharing basis subject to availability of accommodation in the hostel. In case a participant needs hostel accommodation, she / he may indicate this in the Nomination Form.

## Course Fee/Capitation Fee

The Course is sponsored by Ministry of Women & Child Development, Government of India. No fee is required to be paid by the participants or by their departments. However, the TA/DA, hostel and food charges in case opted by the participant except for Lunch, Tea and snacks during actual training will have to be borne by the respective departments.
