Sub: Tender for disposing of Electrical & Electronic Equipment Waste "A" (unserviceable, obsolete and beyond economic repairable (BER) items and Non E-Waste "B" lying in parking area between Hostel building D-II flats at IIPA New Delhi.

Sealed bids/tenders are invited on behalf of Director General, IIPA from the registered recycler/Preprocessors of E-waste with Central Pollution Control Board/Sate Government having authorization for E-waste Disposal for auction of old/obsolete/used e-waste items and also from other scrap vendors for non E-Waste on "as is where is basis", as per list of items attached. All participants have to submit prescribed EMD along with the bid. And for E-waste bid have also to submit the certificate of authorization for disposal of e-waste issued by the Appropriate Authority and fulfilling the terms and conditions of the tender document.

B. <u>Eliqibility/Qualification Criteria:</u>

- (a) The bidder for e-waste shall have to be registered as per e-waste rules with Ministry of Environment, Forests & Climate Change/Central Pollution Control Board/State Pollution Control Committee. Document on registration and validity of authorization shall be produced with the bid. Agencies without having above registration and authorization will be not allowed to participate in the bid.
- (b) The bidder shall have to provide services required at New Delhi/Delhi.
- (c) The firm, bidding for e-waste may enclose sufficient documents regarding execution of Government work order, specifically disposal of e-waste in the past.
- (d) The bidders must enclose GST certificate along with the tender documents.

(C) <u>Bidding Procedure:</u>

 Sealed Bids, super-scribed in bold capital letters: "QUOTATIONS FOR DISPOSAL OF UNSERVICEABLE/OBSOLETE ITEMS INCLUDING E-WASTE AND NON E-WASTE at INDIAN INSTITUTE OF PUBLIC ADMINISTRATION" (who wants to bid for both e-waste and other miscellaneous waste)
 OR

"QUOTATIONS FOR DISPOSAL OF UNSERVICEABLE/OBSOLETE NON E- WASTE ITEMS at INDIAN INSTITUTE OF PUBLIC ADMINISTRATION", (who wants to bid only for miscellaneous waste)
OR

"QUOTATIONS FOR DISPOSAL OF UNSERVICEABLE/OBSOLETE E-WASTE ITEMS at INDIAN INSTITUTE OF PUBLIC ADMINISTRATION" (who wants to bid only for e-waste),

shall be received, not later than upto 1100 Hrs. on 15 October 2025. No Bids will be accepted after this date & time under any circumstances. This office will not be responsible for any postal/courier delay and also for reasons beyond the control of this office.

- c) Incomplete and unsigned quotations are liable to be rejected.
- 1. Earnest Money Deposit (EMD) of 10% of the bidding price (to be indicated by bidder) must accompany with each quotation. This shall be in the form Bank Draft/Pay order of any Nationalized/ scheduled Bank drawn in favor of INDIAN INSTITUTE OF PUBLIC ADMINISTRATION New Delhi payable at New Delhi or through online mode in the bank Account no.18200100002699. IFSC Code-UCBA0001820, UCO Bank, IIPA Branch, New delhi-

110002 without which the tender shall be summarily rejected.

No Cheque/ Money order / Cash shall be accepted. EMD deposit shall not attract any interest. The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidder, shall be returned within one month of the auction date, without any interest. MSMEs are exempted from the requirement of EMD. Intending bidders are required to produce necessary documents in support of seeking exemption from submission of EMD. EMD of the bidders/firms rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of the Institute shall be final in this regard.

- d) All the bids must be delivered/dropped in the tender box placed in Room No.55A (Room of Executive Engineer), Indian Institute of Public Administration, Office Building, Indraprastha Estate New Delhi-110002.
- e) No bid maybe modified subsequent to the deadline for submission.
- f) Bidders may invariably share their telephone, e-mail and mobile numbers to facilitate communication.

(D) General Terms and conditions:

1. The items shall be sold to the highest price of bidder (H1 bidder).

This may result into the items shall be sold to a composite bidder if which has quoted Higher individual price for both e-waste and non e-waste or e-waste and non e-waste shall be so separately to bidders quoting highest bid separately among all the received bids.

- 2. The successful bidder has to make full balance payment in the form of a Bank Draft/pay Order issued in favour of Bank Draft/Pay order of any Nationalized/ scheduled Bank drawn in favor of INDIAN INSTITUTE OF PUBLIC ADMINISTRATION NewDelhi payable at New Delhi or through online mode in the bank Account no.18200100002699, till 16th October 2025, upto 3.00 P.M. after confirmation failing which the offer will be cancelled and EMD shallstand forfeited.
- 3. The successful bidder shall be required to lift all the items from the disposal site to its premises within 3(Three) working days i.e. 18th October 2025 after the payment of the quoted amount. On failure to do so, Institute shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder.
- 4. No items, once disposed to the successful bidder, shall be taken back by the Institute.
- 5. List of unserviceable/obsolete items is at Annexure-II, along with Lot-Wise price quotation format.
- 6. The detail list of items may be referred while submitting the bid.
