Assistant Professor (Dr. B.R. Ambedkar Chair in Social Justice) - One (01) Post:

Area Specialization: Dr. Ambedkar's thoughts & philosophy/Social Justice/Human rights including emancipation of Dalits, Backward Caste/Classes, Women and Minorities, Marginalized Communities, Social inclusion.

Pay Scale and Nature of Appointment:

Academic Level-10 (Entry Pay Rs. 57,700/- Rs. 1,82,400) /- per month with DA, HRA, Annual Increment etc. as per UGC 7th CPC.

Mode of Appointment: On Contract/Deputation basis: Initially for three years, which may be extended on need basis and subject to satisfactory performance for another two years.

Age limit: 35 years (as on the date of advertisement)

Essential Qualification:

(i) Academic Qualification

- A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Political Science/Economics/Law from an Indian University, or an equivalent degree from an accredited foreign university. Relaxation in marks - 5% for SC/ST/OBC/(NCL)/PwD/EWS categories.

(ii) Eligibility Criteria

Candidates must fulfill any one of the following:

- Qualified in **NET (UGC/CSIR)**
- Qualified in **SET/SLET**
- OR hold a **Ph.D. degree** in accordance with UGC Regulations (eligible for exemption from NET)

(iii) Experience

- No mandatory teaching/research experience required (as per UGC norms)
- Relevant experience, if any, will be considered desirable

(iv) Preference will be given to persons belonging to SC/ST, backward Classes or those belonging to other socially and Economically Weaker Sections of the Society.

General Conditions

1. Application form duly filled in all respect by the candidate must be supported by Self attested copies of all certificates, Mark sheets, evidence of teaching, research experience and MA/M.Phil/Ph D/NET certificates, copies of reprints of Published articles, certificate containing the record of date of birth etc. DOCUMENTS

2. Incomplete application form or without signature of candidate shall summarily be rejected.
3. The period of time spent by the candidates to acquire M. Phil and /or Ph.D Degree shall not be considered as research experience.
4. Persons in employment should apply through the proper channel. However, they may send the advance copy of the application with testimonials to IIPA so it reaches before last date. NOC from the current employer must be produced at the time of interview, if shortlisted.
5. The eligibility of the candidates will be determined on the basis of Qualifications/Experience/Publications etc. acquired by them upto the date of advertisement.
6. Mere possession of the minimum educational qualifications or experience does not entitle a candidate to be called for the interview. A limited number of candidates screened on the basis of qualifications and experience will be called for interview.
7. The advertised position is purely on contract /temporary basis and not for Regular/Permanent basis in any way. The employees appointed vide this advertisement shall be governed by rules of temporary employees of the Institute and they cannot claim regularization or permanent absorption against any vacant position in IIPA at any point of time in future. Either party may terminate the employment relationship by giving the other, two (02) months' notice in writing or payment of two (02) months' salary in lieu of such notice.
8. The appointed employee shall have to register himself at the Biometric Attendance System and mark his attendance there regularly.
9. The duration of appointment may be curtailed subject to needs and directions of Dr. Ambedkar Foundation and performance of the candidate assessed by IIPA.
10. No TA/DA will be paid for attending the interview.
11. IIPA reserves the right to modify/withdraw/cancel any communication made to the candidate (s) at any stage in case of any inadvertent mistake in the process of selection may be detected even after issue of appointment letter.
12. IIPA may verify the antecedents of documents submitted by a candidate at any time of appointment or during the tenure of the service. In case it is detected that the documents submitted by the candidates are fake or the candidate has undesirable/clandestine antecedents and has suppressed the said information, his/her service shall be summarily terminated without any notice.
