Report

Introduction

Centre for Urban Studies (CUS) at IIPA organised a two-day national workshop on U-20 Agenda for Municipal Governance from May 2-3, 2023. The workshop covered the last three focus areas of U-20 being (i) championing 'Local' identity, (ii) Reinventing framework for urban governance & planning, and (iii) Catalysing Digital Urban Futures whereas first three areas namely (i) environmentally responsible behaviours, (ii) water security and (iii) climate finance were covered by 1st workshop on U20 Agenda for Municipal Services held during March 22-24, 2023. The workshop was organised in partnership with NIUA (National Institute of Urban Affairs) the secretariate of U-20. 76 delegates from Urban Local Bodies, state agencies and central agencies participated in the workshop.

The keynote address in the workshop was given by Shri Keshav Verma (IAS-r), Chairman, High Level Committee of Govt. of India on Urban Planning whereas Shri S.N. Tripathi (IAS-r), Director General, IIPA, inaugurated the workshop. Shri Hitesh Vaidya (Director, NIUA), Ms. Parul Agarwal (Country Representative, UNHABITAT, New Delhi), Prof. V.K. Dhar (Former Professor, NIUA), Ms. Vineeta Hariharan (former Consultant, MoMSME, GoI), Prof. Ashok Kumar (SPA, New Delhi), Shri R. Srinivas (Consultant, MoHUA), Dr. Surabhi Pandey (Assistant Professor, IIPA), Experts from CUS/IIPA (Prof. K.K. Pandey, Dr. Kusum Lata, Dr. Sachin Chowdhry & Dr. Amit Kr. Singh) and Ms. Swati Pradhan (Associate, Urban Strategy Unit), Shri

Manpreet Singh (Chief Program Officer, NUDM), Ms. Nikita Madan (Senior Environmental Specialist) from NIUA also addressed the different sessions. The workshop had five technical sessions. Draft Recommendations

- 1. Due cognizance should be given to ULBs (urban local bodies-city governments) which are mother institution of democratic governance and also provide systematic development of leadership in a bottom-up manner.
- As Local democracy is the backbone of democratic system, models of local democracy i.e. ward committees, local councils (as operating in Aizawl, Mizoram) should be strengthened.
- 3. Public awareness and participation should be given specific focus under local democracy within the ambit of city governments.
- 4. Special drive should be carried out on Minimum Government Maximum Governance to bring Government closer to citizen with periodic campaign:

- **Public Darbar Public Ke Dwar** with an agenda to list priorities, identify grievances and feedback on service delivery.
- 5. Public representatives should be duly placed in the municipal mainstream through knowledge sharing on budget, programme implementation and exposure visits.
- Take specific measures to adapt water security with mapping of water bodies, development of community structures and conservation plan for recharging and recycling.
- 7. Promote Local Economic Development Plan (LEDP) at Municipal level. LEDP has to cover eco system for micro-economic plan covering skill, service and specialisation with a view to minimise income disparities, promote job creation and local productivity.
- 8. Technical skill should be imparted to all concerned municipal employees to make them aware on recent developments.
- 9. Technically smart municipal employees should be recruited directly from the respective campus as initiated by Ahmedabad Municipal Corporation in early 90's.(it has yielded extremely positive results which are still visible in the revenue surplus nature of ULB)
- 10. 'Technocrats' should be involved in the senior positions of HoD/CEO/Commissioners of urban institutions.
- 11. Inter-departmental coordination should be established with a formal mechanism at city level giving central role to the city government as mother institutions.
- 12. In-house capacity building of elected and not elected functionaries should be taken up under different modes of imparting training.
- 13. Implementation of Master Plan should duly involve planners in the process of evaluation and feedback for planning.
- 14. Extra-budgetary resources should be used to enhance the kitty of funds available for Capex and Opex activities at ULB level.

- 15. Mission Karma Yogi needs to be adapted to develop competency based online/ blended training courses with suitable short-term or long-term module.
- 16. Real estate advisor should be appointed at municipal level to streamline sectoral follow up.
- 17. IEC (Information, Education and Communication) should be used intensively to promote digital awareness among all stakeholders in the city.
- 18. Mobile governance potential should be used fully with various applications for easy access to municipal system.
- 19. ULB should also have Facebook account to disseminate information and update citizen about ULB activities.
- 20. Potential of LED sign board should be tapped for Environment friendly and better access to resources, information and minimise leakages on advertisement fee.
- 21. Digital literacy drive should be launched in each of urban local body.
- 22. Network of Common Service Centres should be developed across the city to operate as a focal point of all municipal services at grass-root level.
- 23. System of licensed service provider should be introduced using PPP approach with a robust contract management system within the command of ULB.
- 24. Unified platform should be created to provide single window approach to facilitate citizen for respective pension/grievance.
- 25. GIS based unified land information system need to be established at town level.
- 26. Government land already occupied by ULB without ownership right should be identified for giving rights by higher level of government.
- 27. Bye-laws and codes should be modified on the basis of current situation.
- 28. Illegal land sub-division and unauthorised construction should be regularised giving due regard to safe environment and public safety.
- 29. Create barrier free infrastructure to mainstream physically challenged persons.

- 30. Apply artificial intelligence in the emerging scenario with suitable adaptation policy at town level.
- 31. Introduce city to city healthy competition for productivity and safe environment. In this regard create network of associations for city managers, city leaders, ULBs and NGOs/CBOs to bring the stakeholders together for mutual learning and follow-up
