Indian Journal of Public Administration invites manuscripts for its special issue on
Constitutional Democracy: Changing Role of People-Centric Administration
July-September (69.3) Year 2023

Background Note

'Constitutional Democracy' literally means a government guided by a Constitution, mostly written or in a few cases unwritten as most famously in the United Kingdom (UK), Israel, and until recently (1986), New Zealand.

Some efforts to draft a Constitution in Israel since 1948 have failed, and the country relies on some evolved system of basic laws, and rights which pass on as having semi-constitutional status. A Parliamentary democracy, Israel's key governmental institutions are the Presidency, Knesset (legislature), a cabinet, a judiciary and the State Comptroller. These institutions operate through an informally organised framework of rules, which also provide for rights and duties of citizens. This framework comprises imperial legislations and rules, Common Law, and constitutional conventions and practices that are binding in a political rather than legal sense. Constitutional rules are amendable there by less formal means than by written constitutional provisions. Thus the spheres of public and private laws there are inter-mingled than neatly separated.

The major sources of constitutional law in Switzerland are the Magna Carta (1297), Petition of Rights (1627), Bill of Rights (1688), Imperial Laws Application Act, (1988), Treaty of Waitangi (1840) and Constitution Act (1986), etc. A rather recent book on the Constitution of New Zealand is by Philip A. Joseph, Constitutional and Administrative Law in New Zealand (Brookers, 2014).

Among the major written Constitutions of the world are those of the USA (1789), Canada (1982). France (1958), Germany (1949), Italy (1947), Japan (1946), and of course India (1950) which is supposed to be the largest written Constitution of the world. Makers of the Indian Constitution regarded such a large written Constitution as an imperative for survival of democracy and the unity in diversity of the nation.

The Second Administrative Reforms Commission (ARC) in a series of Reports recommended a set of objectives which may be summarily listed as follows: Right to Information as Master Key to Good Governance, (1st Report), Unlocking Human Capital: Entitlements and Governance (2nd Report), Crisis Management (3rd Report), Ethics in Governance (4th Report), Public Order (5th Report), Local Governance (6th Report), Capacity Building for Conflict Resolution (7th Report), Combating Terrorism: Protecting by Righteousness (8th Report), Social Capital: A Shared Destiny (9th Report), Refurbishing of Personnel Administration and Scaling New Heights (10th Report), Promoting e- Governance: The Smart Way Forward (11nd Report), Citizen-Centric Administration (12th Report). Contributors may like to deal with these themes wholistically or severally.
