Study 1- Challenges and Prospects of Sustainable Development for SCs and PVTGs with Social Justice.

- To conduct a historical analysis (of W. V. Grigson's work) of the socio-economic, political, and ecological conditions of the Abujmaria tribe in Chhattisgarh.
- To explore the perceptions and practices of the Abujmaria tribe regarding sustainable development in relation to their livelihoods, governance, education, health, culture, and identity.
- To identify and evaluate the opportunities and threats for the Abujmaria tribe to participate in and benefit from the national and global development initiatives and policies that affect their region.

Study 2: Rehabilitation and Re-Integration of Surrendered Naxalites/ Left Wing Extremists: Policies, Challenges and Prospects

 To assess the effectiveness of the surrender cum rehabilitation program for the Surrendered LWEs

- To undertake a comparative analysis of the state's policies with respect to the rehabilitation programs
- To do a comparative analysis of the India's rehabilitation policy for the surrendered LWEs with the other countries policies/ programs addressing the rehabilitation of the extremists
- To generate a profiling of the post surrender economic opportunities undertaken by the beneficiaries in correlation to the official vocational training programs and areas of improvement
