**This Memorandum of Understanding (MOU) promotes academic linkages between the two institutions and facilitates their development of collaborative and mutual programs that will enhance the intellectual life of both institutions, contribute to increased cooperation, and promote mutual understanding. Thus, Indian Institute of Public Administration, New Delhi, and Dr Shyama Prasad Mukherjee University, Ranchi hereafter individually referred to as "The Party" and jointly referred to as "The Parties" have agreed to the following:**

### **OBJECTIVE OF COLLABORATION**

This Memorandum of Understanding (MOU) aims to collaborate in Academic projects and endeavors in areas of mutual interest.

### **SCOPE OF COLLABORATION**

The Parties agree to implement collaborative programs including but not limited to:

- a. Online/offline sharing of innovative ideas in Teaching – Learning and Governance.
- b. Faculty and student mobility.
- c. Organizing seminars/webinars/conferences/symposia through physical and digital mode.
- d. Sharing of scientific information on areas of mutual interest.
- e. Sharing of resources (online and reading room facilities of the library; laboratory).
- f. Undertaking Joint Research Programs where possible.
- g. Academic quality-based collaboration, including publications and internships.

## FINANCIAL ARRANGEMENT

Involvement of funds, if required under this Memorandum of Understanding, will be subjected to approval of relevant authorities/authorities. The financial consideration for any venture will be dealt with separately as per norms of the respective institutions.

## LOCATION OF ACTIVITIES

1. The Parties agree to implement the programs at the Indian Institute of Public Administration, New Delhi, and Dr. Shyama Prasad Mukherjee University, Ranchi.
2. The Parties shall mutually agree upon any changes in the location of the programs.

## MODE OF CONDUCTING THE PROGRAMMES

The programs will be conducted in physical and digital mode.

## CONFIDENTIALITY AND INTELLECTUAL PROPERTY RIGHTS (IPR) PROTECTION

Both institutions shall respect and retain confidentially in each/ any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed, and propelled by the greater academic interest of both institutions and not any other/commercial interest.

This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

## DURATION AND TERMINATION

1. This MOU shall enter into force on the date of signing.
2. The MOU shall remain in force for five (5) years and may be extended for another period of five (5) years by the mutual written consent of the Parties.
3. Either Party may terminate this MOU at any time by giving written notice to the other Party on its intention to terminate this MOU, at least three (3) months before the date of the termination.
4. The termination of this MOU shall not affect the completion of any project/s and program (s) in progress and not completed at the time of termination.

## AMENDMENT

1. This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form an integral part of this MOU.

Such amendment/s or revision/s shall come into force on the date as may be determined by the Parties.
